I understand that I am an independent contractor and am not an agent or employee of North Central Speedway (NCS). I also assume full responsibility for reporting or filing any reports or tax returns with the appropriate authorities on any or all earnings or funds received as a result of my participation in racing events at NCS, including, but not limited to, Federal Social Security taxes, Federal income taxes, State income taxes, Federal and State withholding taxes, unemployment taxes and workers compensation insurance.

Under penalties of perjury, I certify that:

1. The number shown on this form is my correct taxpayer identification number, and
2. I am not subject to backup withholding because: (a) I am exempt from backup withholding or (b) I have not been notified by the IRS that I am subject to backup withholding as a result of a failure to report all interest or dividends, or (c) the IRS has notified me that I am no longer subject to backup withholding, and
3. I am a U.S. person.

I certify that at the time of signing this application, I am in fact at least sixteen (14) years of age.

I have, or will have, familiarized myself with all the NCS (and WISSOTA, if applicable,) rules and regulations, including car specifications and safety rules, and I specifically agree to abide by all NCS (and WISSOTA, if applicable,) rules.

I agree that I shall be the sole spokesperson for myself, the car owner, and the crew in all matters pertaining to compliance with the rules and regulations and I agree and understand that I am responsible for the conduct of my crew.

I agree and understand that by submitting my race car for various technical and safety inspections, I certify that the race car meets all the rules and regulations for participation in NCS (and WISSOTA, if applicable,) sanctioned events, and I understand that the burden of proof will rest upon me to show that I am in compliance with all of the NCS (and WISSOTA, if applicable,) rules and regulations, and I understand violation of various rules can result in a fine, suspension and loss of points.

I agree that all decisions of NCS race officials, regarding the interpretation and application of the NCS (and WISSOTA, if applicable,) rules, and the scoring of positions, shall be non-litigable. I further covenant and agree that I will not initiate any type of legal action against NCS, or an NCS employee or volunteer, to challenge such decisions, to seek monetary damages, to seek injunctive relief or to seek any other kind of legal remedy. I also covenant and agree that I will not initiate any type of legal action against another NCS competitor, crew member, spectator, or volunteer, to seek monetary damages, to seek injunctive relief or to seek any other kind of legal remedy. I understand that if I pursue any such legal action, which violates this provision, then I expressly agree to reimburse NCS, or the NCS employee, competitor, crewmember, spectator or volunteer for all of its attorney's fees and costs in defending against such legal action.

I also agree to release all advertising and promotional rights to my name, car and likeness to NCS and its sponsors.

I further understand that there is no express or implied warranty of safety resulting from publication or compliance with the NCS or WISSOTA rules and that they are intended as a guide for the conduct of the sport and are in no way a guarantee against injury or death to participants, spectators or others.

I understand that if I am paid prize money and found to be illegal afterwards (in the case of fuel testing, for example) I will return the prize money and any trophy to NCS within 3 days. Failure to do so will result in suspension from the track until paid and a judgement for the money will be filed against you.

I have read and understand the "RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK AND INDEMNITY AGREEMENT" and understand that I must sign this release and waiver upon entering the NCS pits for every event.
